- 3 | CMLRE also reserves the right to vary the quantity of the items under procurement
- **4 ONLINE SUBMISSION:** The bidders must submit their offer in PART-I (TECHNICAL BID) and PART-II (PRICE BID) through e-procurement system upto the scheduled time and date. The PART-I shall contain all Techno-Commercial terms and conditions except price. PART-II shall contain price quote.

Complete tender documents along with supporting documents as per the tender conditions below, should be duly filled in and signed in and scanned copy of the same should be uploaded in the e-procurement system.

- i) All the documents, as per Eligibility criteria/ technical specifications
- ii) List of the documents submitted by the bidder must be enclosed on the letter head of the bidder, giving the reference of the tender no. & date and due date of opening.
- iii) All relevant technical literature pertain to items quoted with full specifications (drawing, if any) information about the products quoted, including brochures if any should accompany the quotation.
- iv) A list of reputed clients to whom the firm has supplied similar items to be furnished along with the quotation.
- v) Overwriting and corrections should be attested properly. The quotation should be complete in all aspects and should be duly signed. Incomplete and unsigned quotation will not be considered at all.
- vi) Scanned copy of Tender Acceptance Letter as per ANNEXURE-III
- vii) Scanned copy of Technical Compliance Sheet as per ANNEXURE-IV

- xi) PRICE BID should be on CIF, Kochi.
- xii) The bidders / tenders will not be allowed to make any variations in the price bid or any amendments to commercial offers already uploaded online during the currency of tender and after the date of opening of the tender.
- xiii) Tenderer shall confirm that "the rates quoted by are reasonable and lowest charged to any of your customer". Please enclose documentary proof such as latest purchase order copies etc., to substantiate the reasonability of price.
- xiv) TRADE DISCOUNTS, if any, shall be mentioned
- xv) For imported goods if supplied directly from abroad, prices shall be quoted in foreign currency like USD, Euro, etc as per the currency of origin country.
- xvi) Safe arrival of material up to destination shall be the responsibility of the supplier

#### 5 IMPORTED ITEM OFFERED BY INDIAN BIDDER:

In case the required items are imported by an Indian Agent/ distributor and offered to CMLRE in Indian rupees, the Indian Agent/ distributor shall have to submit the following documents with each supply:

- i) Their foreign principal's invoice or packing list original as well as certified philosophy.
- ii) Certified photocopy of Bill of lading
- iii) Bill of entry original as well as certified photocopy
- iv) Indian Bidders (quoting foreign goods indicating country of origin) holding valid Indian License (IEC) warranty support of foreign manufacturer.
- v) The original mentioned above shall be returned back to the successful tenderer after verification and endorsement.

#### **6 GUARANTEE/ WARRANTY:**

- i) Unless otherwise specified by OEM or specified in the technical specifications, the guarantee / warranty period of item should be minimum 01 year from the date of successful installation/commissioning of equipment to the entire satisfaction of the Consignee.
- ii) In the event of any defects in materials, design and workmanship during the aforesaid period is found due to faulty design or poor workmanship, the defective items shall be replaced by the supplier at site free of cost within 30 days of settlement of warranty claims.
- **iii)** Warranty shall commence from the date of installation and acceptance of the complete equipment supplied under the purchase order/contract.

#### 7 **VALIDITY OF QUOTATION:**

The offers should remain open for acceptance for 365 days from the date of opening of tender.

#### **8** EVALUATION OF BIDS:

- i) Only the technical bid shall be opened online on the date of tender opening. Price bids of only those firms will be considered for opening whose offer would meet all tender requirements including compliance to technical specifications and has passed in all tender conditions and technical / physical (including field trial) evaluation if required.
- ii) After opening of price bids, ranking statement will be prepared and the finalization of successful bidder will be done on L-1 (the lowest price) basis. For foreign currency, and it will be with reference to exchange rate prevailed as on the date of opening of price bid.

iii) A purchase committee constituted by the Director, CMLRE will assess the product supplied/ installed for their quality and tier conformity to the specification provided by the firm in their quotations. Any item identified by the committee to be not as per the specifications or are found to be of inferior quality will be rejected, and the bills towards the supply will not be processed for payment till proper replacements are provided.

#### 9 DELIVERY PERIOD:

The bidders are required to quote delivery period at the earliest indicating commencement and completion of supply on FOR destination basis (For Indian bidders). However in case extension of delivery period becomes essential, the supplier will send their request for extension of delivery period to the purchaser before expiry of delivery period.

#### **10 LIQUIDATED DAMAGES:**

If the supplier fails to deliver the goods within the time to be agreed upon, for delayed deliveries and for delays in installation (whatever applicable) CMLRE reserves the right to levy liquidated damages at the rate of 0.5% per week or par their up to maximum of 5%.

#### 11 INSPECTION AND TESTS:

- i) The purchaser or its authorized representative shall have the right to inspect and/or to test the goods to confirm their conformity to the contract. The purchaser shall notify the supplier in writing of the identity of any representative retained for these purposes.
- ii) Should any inspected or tested goods fail to confirm to the specifications, the purchaser may reject them and the supplier shall either replace the rejected goods and make all alternatives necessary to meet specification requirements free of cost to the purchaser.
- iii) The purchaser shall, at its discretion, have the right to test the ordered material in a government test house or in a test house nominated by the purchaser. In case of failure of the material after testing, the cost of tests as well as of the material shall have to be borne by the supplier.

#### 12 NO ADVANCE PAYMENT:

- i) CMLRE being Government organization, no advance payment will be made.
- ii) Every attempt will be made to make payment within 30 days from the date of receipt of bill/acceptance of goods, whichever is later.
- iii) Payment by irrevocable Letter of Credit after supply and acceptance of the equipment by CMLRE. The payment will be authorized after submission of a bank guarantee for 10% value of the order towards warranty guarantee.
- iv) The performance bank guarantee should be furnished within 15 days from the date of placement of order from a reputed bank (scheduled bank in India or foreign bank operating in India) valid till 60 days after the warranty period.
